The person(s) named on this application assume all risk for personal injury and loss of damage to property. A Mont Ste-Marie season pass is non-transferable. Any violations will result in a loss of privileges. A Mont Ste-Marie season pass holder is obligated at all times to respect the Alpine Skier / Snowboarding Code of Conduct of Quebec (L.R.Q., S-3,1), as well as all the rules and regulations imposed on the use by Mont Ste-Marie management.

N.B. In case of fraud, a passholder will forfeit their season pass immediately without reimbursement.

N.B. A \$100 fee will be charged to replace a lost pass.

N.B. The daily lift ticket rate applies for all forgotten ski passes.

CREDIT POLICY (there are no refunds)

A season pass credit (valid until the end of the next ski season) will be issued with either:

- A) a medical certificate from your doctor, or
- B) proof of permanent relocation more than 200km from Mont Ste-Marie.

All credits are subject to a \$25 administrative fee and calculated as follows: 75% credit between November 20th and December 25th, 2011; 50% credit between December 26th, 2011 and January 15th, 2012. After January 15th, 2012, no credit will be issued.

* **MAX PASS: Must be purchased in a group of 4. Only 1 payee per group. Does not include the following dates: December 26th to 30th, 2011 incl. Can not be upgraded to Dual Mountain. No credits will be applicable on MAX Pass. May be combined with the Almost Anytime Pass to create your group.**

** **ALMOST ANYTIME PASS: Must be purchased in a group of 4. Only 1 payee per group. Valid anytime before December 25th, 2011. Valid Weekdays from December 26th, 2011 until March 9th, 2012 and valid anytime after March 11th, 2012. May be combined with the Max Pass to create your group. Can not be upgrade to Dual Mountain.**

*** **Must be purchased in a group of 4. Only 1 payee per group.**

**** **Age at December 31, 2011**
